The Purpose of good classroom management is to provide an environment conducive to learning and experiencing our faith. Catechists have the right to teach and students have the right to learn. An extremely disruptive student interrupts the learning experience and upsets the class.

Students are expected to abide by these rules:

- 1. Follow the rules the catechists and students have come up with or agreed upon in each classroom.**
- 2. Show respect with your words and actions to everyone around**

you. Our policy in handling disruptive students is as follows:

First the catechist will discuss the situation with the student; on the second occurrence, the student will be sent to the Religious Ed./Youth Ministry office and will stay there and a parent will be notified. If a situation continues uncorrected, the Youth Minister or DRE will make an appointment with the parents and the student for a meeting to discuss the situation.
